Marlene Barrie, Senior Amicus Rep in South Glasgow, has represented 11 members who have had successful claims for ill health effects as a result of exposure to x-ray film processing chemicals.

one of these claims would have been successful without the research carried out by the late Marjorie Gordon – a New Zealand Radiographer who was the first to connect her ill health with her workplace.

Marjory's daughter Phillippa Martin has now taken over the organisation of a self help group for the Chemically Injured, and Marlene has recently spent a week with her and members of the group in New Zealand.

As one of these chemicals is also present in sterilising solutions, others who may have been chemically injured include Biomedical Scientists, Pharmacy Technicians, Nurses, Podiatrists and Dentists etc.

If you feel that you may be suffering ill health as a result of chemical exposure at work, you may be interested in the presentation Marlene is giving to this month's Branch Meeting.

Earlier this month, all amicus group representatives should have received a copy of the union's publication 'the activist'. The launch issue contains numerous articles covering the full range of amicus membership, including the NHS. One item which may be of interest is the launch of the amicus 'top bosses' award. The awards encompass a prestigious award for best employer and an amicus charter mark for employers that meet certain criteria. Scottish NHS Bill Progresses

The NHS Reform (Scotland) Bill has passed its first major hurdle in the Scottish Parliament. The Health and Community Care Committee endorsed the general principles of the Bill which, inter alia, abolishes NHS Trusts. However, the committee expressed some concerns over the culture change required to ensure that the NHS and other organisations such as local authorities worked together for the benefit of patients. The committee also queried whether the move away from Trusts would be cost neutral complaining that they 'not been given a breakdown of costs for the new bodies'.

Agenda for Change Pay Rates 'below market rate'

According to management consultants the Hay Group, almost all the pay rates set by Agenda for Change are significantly below the market median for both the public and private sectors. For example, the proposed bands 3 and 4 are about 17% below market rate for the public sector, band 5 is 12% below, band 6 is 6% below. Band 7 is 2% below and band 8a approximately equal. Bands 8b and 8c are 3% above, and 8d is 9% above. However, nearly all of these figures are worse when the comparator is the private sector; for example band 8a is 5% below and band 6 is 9% below market rate.
