One of the most significant changes now in effect is that much of the process for deciding some of these problems are determined by SPRIG (the Scottish Pay Review and Implementation Group), a Scottish wide partnership group including

Amicus Regional Officer Michael Fuller. SPRIG have drawn up a timetable for job matching (see table) that breaks the process into "manageable" chunks. However, just as the process for introducing AfC will take many months this newsletter will cover many of these issues over the coming year.

Paid Parental Leave Contractual?

he new Agenda for Change NHS Terms and Conditions Handbook states that "In Scotland. the statutory framework includes legislation on Staff Governance as set out in the NHS Reform (Scotland) Act 2004 and the Staff Governance Standard. Compliance with this standard includes implementation of Partnership Information Network (PIN) Guidelines, which define a minimum standard of best employment practice. This Handbook should be read in

conjunction with the provisions of the PIN quidelines as listed in Annex v "

The Handbook came into effect with the implementation of AfC on 1st December 2004 and subsequently PIN Guidelines are now contractual.

The paid parental leave provisions of the Family Friendly Policies PIN Guideline should now be considered in the same contractual light.

A To Do About Overtime

There has been much consternation within the Service over the introduction of the new AfC overtime rate of time and half (double time for public holidays). This has been particularly the case around overtime for Sundays and also waiting time initiative payments of triple time. As far as the waiting time initiative is concerned advice from SPRIG is going to the minister allowing continued payments for this work. SPRIG is also proposing a phasing-in of the introduction of AfC overtime payments for Sundays.

Annual Leave - The Big Steal

Public holidays for 2004-05 are to remain the same as previous years for Christmas and New Year. Shamefully however, and contrary to the advice of SPRIG and partnership principles, the health minister Andy Kerr has decided in effect to steal a day of annual leave for this leave year from everyone gaining as a consequence of AfC. This to be applied on a pro-rata basis to part time staff.

Job Matching and **Evaluation**

The job matching and evaluation process within health boards leading to assimilation onto the new pay bands will start in January. Amicus Reps will be at the forefront of this process in two ways. Amicus Reps will participate as full members of both the matching and evaluation panels, thus reinforcing the impartial decision making of these panels. These Reps are currently undergoing intensive expert training. Further, Reps will be working jointly with local management to develop job descriptions and advising members ensuring as best as possible that their aspirations can be met. Local and Senior Reps are available throughout the service to keep members advised on how things are progressing.
