Government delays hospital PFI schemes

A ccording to the British Medical Journal, several private finance initiative (pfi) schemes for hospitals are to be reviewed by the UK Government because of increasing concerns about the financing of the NHS.

Three schemes are reported to be under scrutiny. A £1.2 billion proposal to refurbish St Bartholomew's and the Royal London Hospitals was initially given approval by the North East London Strategic Health Authority and nearby Primary Care Trusts but is now the subject of review by the Treasury and the Department of Health.

Two other PFI schemes are also reported to be under review Plymouth Hospitals NHS Trust and Hillingdon Hospital in West London.

hilst PFI projects have had some degree of success elsewhere in the public sector, within the NHS they seem doomed to be dogged by controversy and financial failings. Not really surprising when they are little more than a very expensive form of hire purchase.

Scottish press turns good news into NHS failure

A t the end of January, both the tabloid and broadsheet press in Scotland ran stories with headlines suggesting that the number of NHS "managers" had soared. In fact the figures which they quoted as being for "senior managers and administrators" refer to ALL grades of administrative, clerical and management staff i.e. it includes clerks, secretaries, receptionists etc, the vast majority of whom could not be described as senior management or even management. The facts on NHS staffing in Scotland are reasonably good news, and thus rather boring to Scotland's press:

Safer workplaces with unions	A new report from the Health and Safety Executive states that non-unionised workplaces have less consultation, less staff participation and a worse safety culture than unionised workplaces. According to the report, where unions are not present there is "no evidence that workers requested or initiated new participatory or consultative arrangements" such as safety committees. In most cases managers, H & S officers, employee reps and workers were not aware of relevant health and safety regulations.
