## Scottish NHS Conference calls for 35 hour week

he Conference, which was held on the 3rd March, was addressed by Regional Secretary (Scotland) John Quigley on the rationale behind the current union merger proposal. This was followed by National Secretary (Health) Gail Cartmail who spoke on the national (UK) NHS picture. Regional Officer Michael Fuller then updated the Conference on the situation in NHS Scotland. Video extracts of these addresses may be downloaded from the Branch website. The conference passed two motions,

both submitted by Donald Sime (NHS Greater Glasgow).

he first called on the union to campaign and negotiate for a 35 hour week within the NHS coupled with 12 days public holidays and 4 weeks parental leave per child for the whole NHS in line with the Scottish Partnership Information Network Policy. The second motion called on the union's National Executive to ensure that the union's current and future structures took full account of the devolved administrations within the UK.

Employment trends	<ul> <li>The Government's Office for National Statistics publishes a Social Trends report annually. This year's report reveals that at Spring 2005 :</li> <li>The employment rate of working-age males was 79% (up from 75% in 1993 and down from 92% in 1971) and that of females 70%.</li> <li>Approx 16% of working age households were workless (i.e. no-one of working age was in employment)</li> <li>88% of working-age people with a degree or equivalent were in employment. For those with no qualifications the figure is 48%</li> </ul>
New equality body approved	A new Commission for Equality and Human Rights (CEHR) is to be estab- lished with effect from October 2007 when it will replace the Disability Rights commission and the Equal Opportunities Commission. It will also take over the functions of the Commission for Racial Equality in 2009. The CEHR will produce a regular "equality" check for Britain and work with individuals, communities, businesses and public bodies to find ways to ensure that everyone in society is given equality of opportunity to achieve their full potential.
Independent health sector treatment slammed	An article in the British Medical Journal has attacked the increasing use in Eng- land of Independent Sector Treatment Centres (ISTCs). The article by a profes- sor of orthopaedic and accident surgery states that the number of patients sub- sequently seen in the NHS who have problems resulting from poor surgery in the ISTC is too great. He gives examples of incorrectly inserted prostheses, technical errors and infected joint replacements. The ISTCs are employing junior specialists from abroad who in their own country are normally under the supervision of a senior consultant, but in the ISTC are allowed to operate without supervision. This means that NHS patients treated in the ISTC are being given an inferior standard of care compared to ei- ther NHS patients in NHS facilities or patients in the junior specialists' own countries (e.g. Hungary, Croatia)
