# EARLY IMPLEMENTATION OF AGENDA FOR CHANGE INCREASES TO PAY SCALES FOR 2004/5 FOR NHS STAFF WORKING IN EARLY IMPLEMENTER SITES

1. With effect from 1 April 2004 the national salary scales for staff working in the Agenda for Change "Early Implementer" sites will be increased by 3.225%. Revised salaries for full time employees are set out in the attached Annex A to this letter.

#### **High Cost Area Supplements**

- 2. The minimum and maximum payments for High Cost Area Supplements have also been uprated by 3.225%. Details of the new rates are listed at Annex B.
- 3. El employers are asked to ensure that the necessary arrangements are made as soon as possible to implement these new pay scales.
